Circular No. 01/2020 (MMD)

Mandatory Guidelines regarding Consolidated UN security Sanction Relating to Democratic People Republic of Korea (DPRK) for ships calling Pakistani Waters/pots.

Notice to all ship owners, ship agents, ship manning agencies, port authorities and terminals and all those concerned with import/export of cargo via sea

Regarding the Ministry of Foreign Affairs SRO's 1491(I) 2019, 1492(I) 2019, 1465(I) 2019 and U.O Note No. ACDIS-8/6/2019, Mercantile Marine Department please to issue following guidelines;

- 1 An 'Exception List' based on the UN sanctions i.r.o. DPRK has been prepared as per attached Annexure which shall be used as a handy checklist for enforcing the said sanctions.
- 2 The concerned section of the Mercantile Marine Department (MMD) shall generate no objection certificate after referring the said checklist to ensure that clearance is NOT generated for any vessel as mentioned in the exception list.
- 3 The ship Registration section of the MMD shall refer to this exception list prior registration of any craft / vessel to ensure (implementation of the under the sub-head " Interdiction and Transportation") NOT to register any of those vessels which may have been de-registered by another member state of IMO:
- 4 Mercantile Marine Department shall de-register any vessel about which intimation is received from the relevant control authorities regarding its involvement in activities prohibited by the specific UN-resolution.
- 5 Therefore, it is advised to all stake holders that they shall consult the 'Exception List' prior fixing import/export of cargo or applying for ship registration. Owners of ship registered with MMD. shall also make sure that their ships/crafts are not involved in any activity(ies) prohibited by the UN resolution.
