**Subject: Gazette of Pakistan S.R.O. 509 (I) 2021**

Please find enclosed for appropriate action, copy of the latest Gazette of Pakistan Statutory Regulatory Order (S.R.O.) no. 509 (I)/2021 dated 20 April 2021, reflecting amendments made to the Sanctions List of entities/individuals designated by UN Yemen Sanctions Regime.

2. In pursuance of the UN Security Council resolution no. 2402 (2018) and its previous resolutions, S.R.O.s are issued by the Government of Pakistan under the UN Security Council Act, 1948, whenever the UN Yemen Sanctions Committee list is updated/changed, to provide legal coverage for domestic implementation of sanctions measures against listed individuals/entities.

3. Vide its resolutions 2140 (2014), 2216 (2015), 2266 (2016), 2342 (2017) and 2402 (2018), the UN Security Council has obliged all Member States to take following measures against designated individuals/entities under Chapter VII of the UN Charter:

- a. Asset Freeze: to freeze all funds, other financial assets and economic resources that are owned or controlled, directly or indirectly, by the individuals or entities designated by the Committee, or by individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them; no funds, financial assets or economic resources to be made available to or for the benefit of such individuals or entities;
- b. Travel Ban: Prohibits the entry into or transit through States' territories of individuals designated by the Committee; and
- c. Arms Embargo: to prevent the direct or indirect supply, sale or transfer to, or for the benefit of designated individuals and entities and those acting on their behalf or at their direction in Yemen, from or through their territories or by their nationals, or using their flag vessels or aircraft, of arms and related material of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment, and spare parts for the aforementioned, and technical assistance, training, financial or other assistance, related to military activities or the provision, maintenance or use of any arms and

related material, including the provision of armed mercenary personnel whether or not originating in their territories.

**ORDER**

S.R.O. No. 509 /2021 - WHEREAS the United Nations Security Council vide its resolutions Nos. 2140(2014), 2216(2015), 2266(2016), 2342(2017) and 2402(2018) concerning Yemen has directed arms embargo, travel ban and assets freeze against certain individuals and entities under Chapter VII of the United Nations Charter;

AND WHEREAS the United Nations (Security Council) Act, 1948 (XIV of 1948) enjoins upon the Federal Government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

NOW, THEREFORE, in exercise of the powers conferred by Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government is pleased to order that the individual listed in the Annexure to this shall stand subjected to travel ban arms embargo and assets freeze, in accordance with the aforesaid UNSC resolutions with immediate effect.

**Other information:** Sultan Saleh Aida Aida Zabin has engaged in acts that threaten the peace, security and stability of Yemen, including violations of applicable international humanitarian law and human rights abuses in Yemen. Zabin has played a prominent role in a policy of intimidation and of use of systematic arrest, detention, torture, sexual violence and rape against politically active women. Zabin as director of CD is directly responsible for, or by virtue of his authority responsible for, and complicit in the

use of multiple places of detention including house arrest, police stations, formal prison and detention centres and undisclosed detention centres. In these sites, women including at least one minor, were forcibly disappeared, repeatedly interrogated, raped, tortured, denied timely medical treatment and subject to forced labor. Zabin himself directly inflicted torture in some cases.
