
Subject: **FISHING VESSELS REGISTRATION RULES, 2021.**

NOTIFICATION

Islamabad, the 11th August, 2021

S. R. O. 1057(I)/2021.—In exercise of the powers conferred by section 449 of the Pakistan Merchant Shipping Ordinance, 2001 (LII of 2001), the Federal Government is pleased to make the following rules, namely:

PRELIMINARY

1. **Short title, application, and commencement.**— (1) These rules shall be called the Fishing Vessels Registration Rules, 2021.

(2) These rules shall come into force at once.

(3) These rules shall apply to sea-going fishing vessels propelled by mechanically means.

2. **Definitions.**—(1) In these rules, unless the context otherwise requires,—

- (a) "administrative Division" means the Division to business maritime affairs stands allocated;
- (b) "central register" means the register of all fishing boats maintained by principle officer of Mercantile Marine Department, Karachi;
- (c) "certificate" or "CoR" means a certificate of registry granted under sub-section (3) of section 433 of the Ordinance;
- (d) "engine driver" means the person in charge of propelling machinery including auxiliary machinery of a fishing vessel;
- (e) "fishing vessel" means a vessel used commercially for catching fish or other living resources of the sea;
- (f) "fishing vessel's registry" means principle officer of mercantile marine department, Karachi or a person duly authorized by administrative Division;
- (g) "foreign vessel" means a vessel owned-wholly or partially by a foreign national;
- (h) "foreign joint venture" includes any company registered in Pakistan having shareholding, wholly or partially of a foreign national;
- (i) "gross" means the gross tonnage of the vessels as registered under the Ordinance;
- (j) "Ordinance" means the Merchant Shipping Ordinance, 2001 (LII of 2001);
- (k) "Owner" means, in relation to a registered fishing vessels, the person or persons and companies who are for the time being shown as owners in the registration book maintained under the Ordinance;
- (l) "port of registry" means any port which is declared as a port of registry under section 16 of the Ordinance;
- (m) "radio installation" means radio equipment as prescribed by Paksitan Telecommunication Authority;
- (n) "skipper" means the person in command of a fishing vessel, or in-charge of the navigation of such fishing vessel;

- (o) "surveyor" means the person appointed under the Ordinance to survey any type of fishing vessel; and
- (p) "wooden or primitive built fishing vessels" means fishing vessels made of wood of local design.

3. **Application for certificate of registry.**—(1) Every application for the grant of a certificate of registry of a Pakistani fishing boat shall be made on the format as specified in Appendix A, to the registrar of fishing vessels nearest to the place where the owner resides or where the fishing boat is built or based.

(2) Every application under sub-rule (1) shall be accompanied by –

- (a) the particulars of the fishing boat in Appendix-A;
- (b) the declaration of the ownership by the applicant in Appendix-B or C as the case may be;
- (c) the documents of the title to the fishing boat; and
- (d) the builders' certificate.

(3) Every application for the grant of certification of registry of an existing Pakistani fishing boat which is registered under the Coastal Vessel Act, 1838 (XIX of 1838), shall make an application in the format, as specified in 'Appendix A', without payment of any fee, to the Registrar of the port of Registry of that fishing boat:

Provided that foreign vessels and foreign joint venture shall not be registered.

(4) Every application under sub-rule (3) shall be accompanied by; -

- (a) the particulars of the fishing boat in Appendix-A; and
- (b) the original certificate of registry previously granted under the Coastal Vessel Act, 1838 (XIX of 1838).

4. **Name of the fishing boat.**—(1) When applying for the certificate of registry, the owner shall specify the name which he proposes to adopt for the fishing boat.

(2) If the name proposed by the owner is the same or similar to the name by which any other fishing boat has been previously registered at any port of registry, the registrar may require the owner to suggest some other name under which the fishing boat may be registered.

(3) When the name suggested by the owner under sub-rule (2) has been approved by the registrar, the fishing boat shall be registered under that name within sixty days.

5. **Official number.**—(1) On scrutiny of an application under rule 3, if the registrar is satisfied with the nationality of the applicant and his title to the fishing boat, he shall assign to the fishing boat an official number from a consecutive series maintained at each port of registry preceded by three distinguishing letters, for Karachi: KHI, for Gawadar: GWD, for Port Qasim PQA which indicates the port of registry notified.

(2) The official number once assigned to a Pakistani fishing boat shall not be changed except when the fishing boat is registered again at another port of registry, nor shall the official number be registered for another vessel.

6. **Manner of ascertainment of the tonnage of Pakistani fishing boat.**—(1) Every owner of a fishing vessel shall cause to ascertain its tonnage under the Merchant Shipping (Tonnage Measurement of Ships), Rules, 2002. However, the tonnage of fishing boats, less than twenty four meters in length, may be measured by the Registrar of Fishing Boats after the survey.

7. **Certificate of the registry.**—(1) The Registrar shall, after the tonnage of a Pakistani fishing boat has been ascertained, enter the particulars specified under the Ordinance in the register kept by him for the purpose and grant a certificate of the registry within sixty days from the date of application.

(2) Every certificate of registry granted under sub-section (4) of section 433 of the Ordinance shall be as per the format specified in Appendix D;

(3) The certificate of registry shall, on-demand by the registrar of fishing, any officer of the customs, any officer of Pakistan Maritime Security Agency or by the Surveyor of the mercantile marine department, be produced by the owner, the skipper or any other person in charge of the fishing boat.

8. **Manner of the painting of name and official number on the fishing boat.**—(1) The distinguishing letters indicating the port of registry, the name of the fishing boat by which it is registered and the official number assigned to it under rule 5, shall be painted in English and Urdu alphabet in white oil color against a black background on both quarters of the fishing boat near the stern.

(2) All the letters painted shall be of such size as the registrar may determine in each case but shall not be less than one decimeter in height and two centimeters in width.

(3) The letters referred to in this rule shall also be painted on the rescue boat (dinghies) placed in the fishing boat.

9. **Change of name.**—(1) The name of a fishing boat under which it has been registered shall not, after such registry, be altered or changed except with the approval of the registrar.

(2) Each application for the change of name of such a fishing boat shall be made to the registrar of the fishing boat's port of registry and shall specify the reasons for the proposed change.

(3) The registrar, may if he is satisfied that the change proposed is reasonable and necessary, approve such change within sixty days from the date of receipt of application.

(4) Where the name of a fishing boat, which is mortgaged, is sought to be changed, the consent of the mortgage shall also be obtained for the proposed change.

(5) The new name which has been approved by the registrar shall be entered in the certificate of registry of that fishing boat, and shall accordingly be painted on the fishing boat in accordance with rule 8.

10. **Registrations of alterations.**—(1) An application for alterations of a fishing boat's particulars relating to her certificate of registry shall be made in Appendix-E within thirty days of such alterations to the registrar of the port where the fishing boat is registered.

(2) Where the alterations under sub-rule (1) do not materially affect the dimensions or the tonnage of the fishing boat, the registrar shall enter the alterations in the register and also in the certificate of registry of the fishing boat.

(3) Where the alterations under sub-rule (1) materially affect the dimensions or the tonnage of the fishing boat the registrar shall proceed to register the fishing boat *de novo*.

(4) Where the registrar proceeds to register the fishing boat *de novo* as required by sub-rule (3), he shall do so within sixty days on receipt of application or completion of alteration, whichever is later.

11. **Transfer of registry.**—(1) If all the persons having an interest in a fishing boat, whether as owner or a mortgage, desire that the registry of the fishing boat should be transferred from one port to another, they may apply in Appendix-F to the registrar of the port of registry for such transfer.

(2) The registrar of the port of the registry shall, if he is satisfied that the proposed transfer is unobjectionable, transmit the particulars of the fishing boat and the encumbrances if any thereon to the registrar of the intended port of registry.

(3) The registrar at the intended port of registry, after he is satisfied that the new official number with the distinguishing letters of the port is duly marked on the fishing boat as per provisions of rule 8, shall issue a fresh certificate of registry and communicate to the registrar of the original port of registry the official number assigned to the fishing boat and the date of its registry.

12. **Closing of the registry.**—(1) Where the registry of a fishing boat is transferred under rule 11, the registrar of the original port of registry shall close the registry of the fishing boat in his register.

(2) Where the registry of a fishing boat at any port is closed due to any reason, the registrar of the port shall forthwith submit to the principal officer mercantile marine department - Karachi a statement of the particulars of the fishing boat registry of which is closed and the circumstances in which the registry is closed.

13. **Transfer of fishing boat or interest therein.**—(1) The owner, or in the case of joint ownership all the owners, of a fishing boat, desiring to transfer such fishing boat or any interest therein, shall apply to the registrar of the port of registry for permission to do so.

(2) The Registrar shall, after making such inquiry as he thinks necessary, approve the transfer of ownership of fishing boat or any interest therein within sixty days from the date of receipt of application.

(3) If the proposed transfer is approved, and after the sale has been effected, the transfer shall present to the registrar of the port a declaration of ownership the instrument of transfer and the existing certificate of registry of the fishing boat and thereupon, the registrar shall enter the particulars of the transfer in his register and issue a fresh certificate of the registry within sixty days.

14. **Mortgage of a fishing boat.**—(1) Every instrument of mortgage of a fishing boat or any interest therein shall be in Appendix-G or Appendix-H, as the case may be.

(2) The registrar shall, after satisfying himself that the instrument of mortgage has been properly executed, record the same in his register with the date and hour of acceptance and shall also make an endorsement to that effect on the mortgage instrument.

(3) Where there are two or more mortgages on the same fishing boat, their respective priorities shall be indicated in the register in the appropriate column by the letters A, B, C ... in alphabetical order.

(4) Where a fishing boat belonging to a company or a cooperative society is mortgaged, the registrar shall not register the mortgage unless it has also

been registered with the registrar of Companies under the Companies Act, 2017 (XIX of 2017) or any other law relating to co-operative societies for the time being in force.

(5) When the mortgage debt is fully discharged, the registrar shall, after satisfying himself that the receipt endorsed on the mortgage instrument is in order and that it is properly witnessed and where the mortgage is by a company or a co-operative society, also that a memorandum of satisfaction has been entered in the register of changes of the Companies Act, 2017 (XIX of 2017) or, as the case may be, under the Co-operative Societies Act, 1912 (II of 1912), make an entry in the register relating to the discharge of the mortgage.

(6) No payment of any installment of a mortgage debt shall be recorded in the register.

15. Transfer of ownership by operation of law.—(1) Where the title to a fishing boat devolves on any person by operation of law, such person shall apply to the registrar specifying the circumstances in which he has acquired title to the fishing boat and also adducing evidence of such acquisition.

(2) If the registrar, after making such inquiry as he thinks fit, is satisfied with the claim of the applicant, he shall register the particulars of the change of ownership in his register and also endorse the particulars in the certificate of registry of the fishing boat.

16. Fishing boats owned by minors.—(1) Where a fishing boat is registered in the name of a person as the guardian of a minor, the ownership of the fishing boat shall remain with the minor, and on the obtaining of Computerized National Identity Card (CNIC), he / she may apply to the registrar for altering the entries in the register relating to the fishing boat. The registrar shall then issue a fresh certificate in the name of the applicant.

(2) No fees shall be charged for issuing a certificate of registry under sub-rule(1).

(3) Where the registrar proceeds to issue a fresh certificate in the name of the applicant as required under sub-rule (1) he shall do so within sixty days from the date of application.

17. Issue of duplicate copies of certificate.—(1) The registrar may on an application made by the owner in this behalf, issue a duplicate copy of a certificate of registry marked "DUPLICATE" in red ink, if he is satisfied that the original certificate has been destroyed, lost, mislaid, mutilated or defaced.

(2) Every application for a duplicate copy of a certificate of registry shall be accompanied by a declaration regarding the circumstances in which the original certificate has been destroyed, lost, mislaid, mutilated or defaced.

(3) Where a duplicate copy of a certificate of the registry has been obtained on the ground that the original has been lost or mislaid, and such original is subsequently found or received by the owner, he shall forthwith surrender the original certificate to the registrar who shall cancel the same.

(4) A duplicate copy of the certificate of registry shall not be granted on the ground that the original has been mutilated or defaced unless the mutilated or defaced certificate is surrendered to the registrar.

18. Central register.—(1) The principal officer mercantile marine department, Karachi shall maintain a central register which shall contain all the entries recorded in the registers kept by the registrars.

(2) On completion of the registry of a fishing boat at a port, the registrar of the port shall immediately transmit to the principle officer mercantile marine department, Karachi a copy of the entires in his register relating to the fishing boat.

19. Inspection of register and supply of copies of entries.—(1) The register maintained by a registrar shall, on the application made in this behalf and payment of the fee specified in Appendix-J, be open to inspection during office hours by any person.

(2) A certified copy of any entry in a register may be granted by the registrar to any person on an application made in that behalf and payment of the fee specified in Appendix-J,

20. Declaration of ownership.—Every declaration of ownership under these rules shall be made before a registrar, first class judicial magistrate, or an oath commissioner.

21. Fees.—Fees shall be levied under these rules at the rates and for the purposes specified in Appendix-J and challan evidencing the payment thereof shall be provided to the registrar along with the application for recording the transaction.

22. Entry of particulars of existing fishing boats.— (1) The owner of every fishing boat which was registered before the commencement of these rules shall within three months of such commencement produce before the registrar the relevant certificate of registry; Provided that the Director General of ports and shipping may, for sufficient reasons, extend the period up to six months.

(2) The registrar shall enter in his register the particular of the fishing boat and any outstanding mortgage of the fishing boat or any interest therein and shall also assign a new official number to the fishing boat.

(3) The official number assigned under sub-rule (2) shall be painted in the manner specified in rule 8 in the place of the number, if any, already painted thereon.

23. Statement relating to the crew to be maintained.—(1) Every owner or skipper of a sea-going fishing vessel shall maintain a statement of the crew on a register as per the format given in Appendix-I.

(2) Every change of crew including skipper shall be entered with the place, date and time of joining or signoff.

(3) Whenever any change occurs the copy of the statement shall be communicated to the registrar of the port of registry of the fishing vessel.

24. Appeals.—Any person aggrieved by the decision of the registrar in respect of the transfer of ownership of fishing boat or any interest therein, mortgaging of a fishing boat or grant of certificate of registration, may file appeal in writing before the Director-General ports and shipping within ninety days from the date of receipt of the decision of the registrar.
