16	Are navigation lights in good order			
17	Is the Magnetic compass and or Gyro in good working condition and annual service certificate available			
18	Is the craft fitted with a main deck boundary coaming and scupper arrangement that is effectively plugged during operations?			
19	Is the craft equipped for dealing with small oil spills?			
20	Are air pipes/heads and vents on deck are in good condition?			
21	Are the bunker manifold and associated valves in good order, blank flanges fitted outboard of the manifold valves on both sides?			
22	Is machinery space clean and free from obvious leaks and is the overall standard of cleanliness and maintenance satisfactory?			
23	Are the safeties of the engines and other machinery are working satisfactory?			
24	Is Emergency Fire pump working satisfactory and capable of giving sufficient pressure?			
25	Is means of Emergency power supply are in good working condition?			
26	Are the engine room bilges clean and free from oily water?			
27	Are the engine room machinery maintained properly, color of exhaust smoke satisfactory?			
28	Is the engine room flooring plates secured properly?
